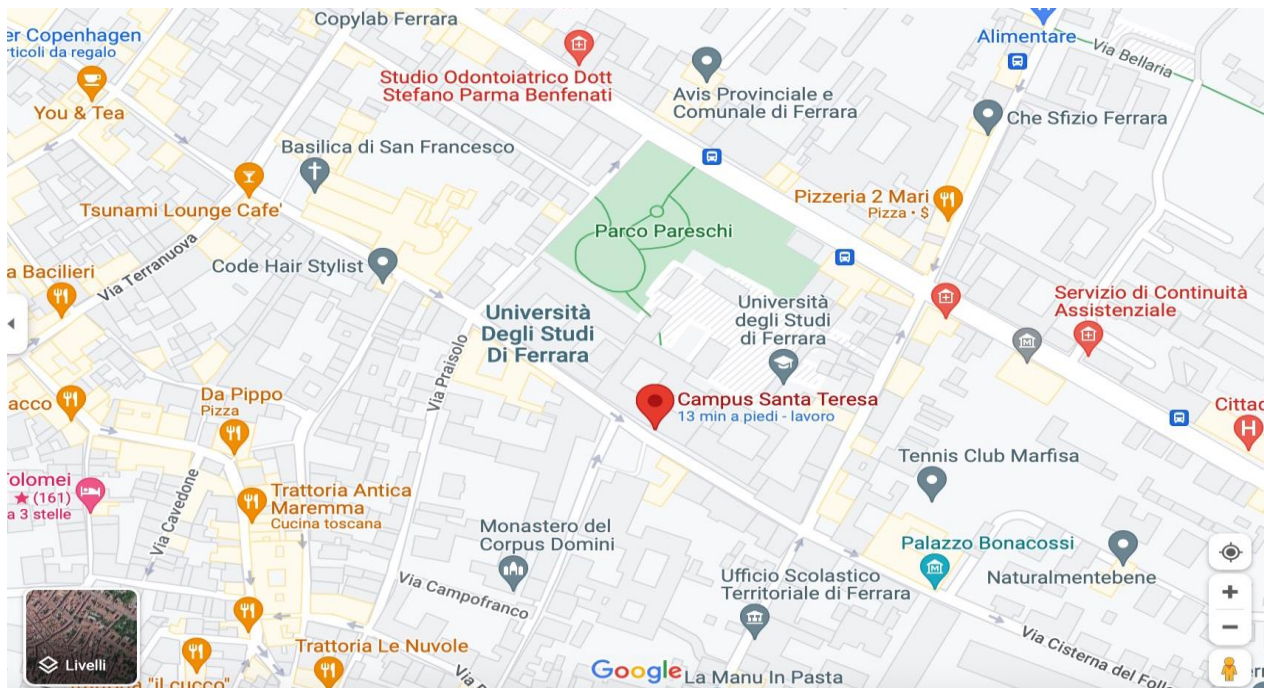

## THE AREAS

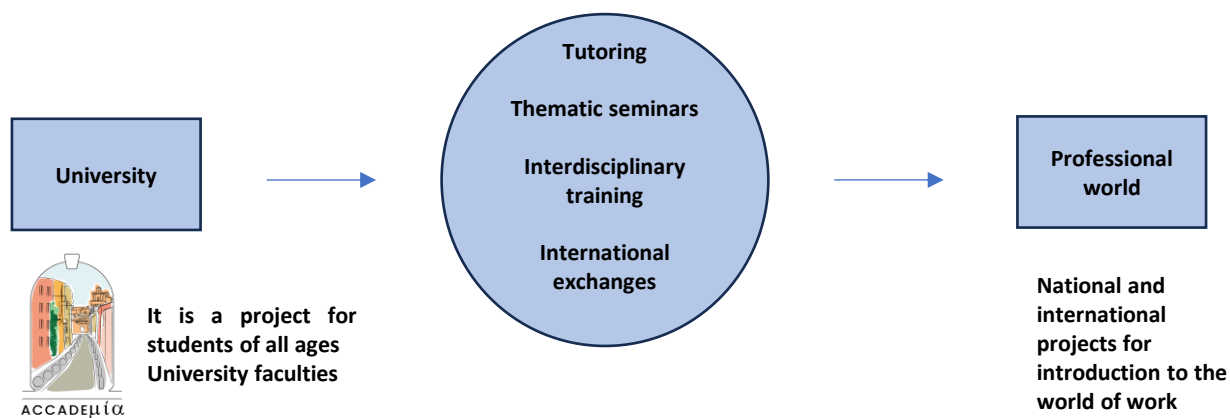

## TRAINING PROJECT

The Santa Teresa Campus enriches the university study path with a 50-hour annual training project signed by the student at the beginning of the Academic Year. On Campus the growth path develops in an international environment conducive to study, in a climate of discussion and freedom. All this is favored by a continuous training relationship with teachers of international origin and tutors who will accompany the student both in the context of scientific in-depth study and in the introduction to the world of work. This model is designed together with each student and will synergistically propose thematic meetings and personalized paths so that the student can discover skills and potential in a manner consistent with the chosen study plan and suited to university commitments. The thematic meetings are part of the «ACCADEMIA - Con il Cuore indiviso» project (<https://www.fondazionezanotti.org/education/accademia/>) which offers a structured, modular and open path composed of interdisciplinary courses and thematic insights with teachers and personalities of national and international importance capable of generating relationships and knowledge aimed at broadening the horizons of the participants. The path will be monitored together with the tutors through interviews carried out during the stay on the Santa Teresa Campus. Thanks to collaborations with national and international bodies and institutions, the student is placed in a wide-ranging context that generates opportunities.



## ADMISSION REQUIREMENTS

This competition notice is for students who in the a.y.2024/2025 :

- They enroll/are enrolled in any university level school or institute
- Have no criminal convictions and have no pending charges
- They are free from pathologies incompatible with community life

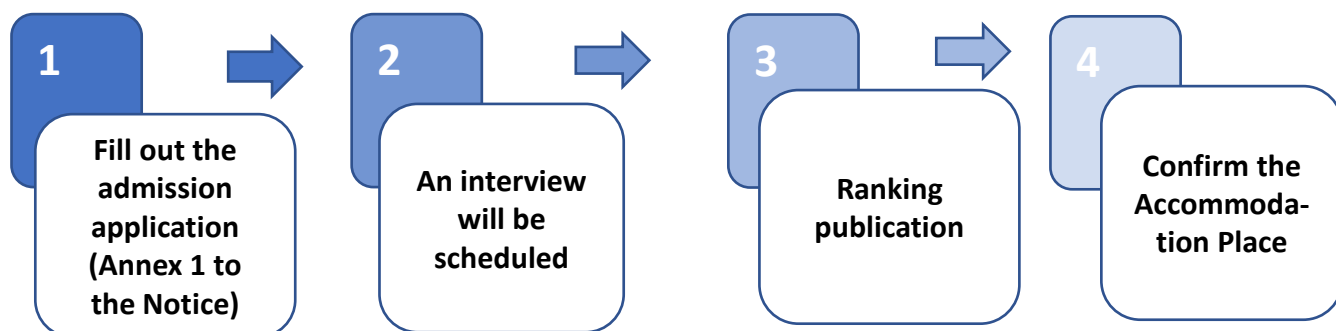
For students enrolled in years subsequent to the first year in the a.y,2024/2024

- University curriculum with an arithmetic average grade equal to or higher than 24/30

## ADMISSION

The admission process is reported schematically and then explained in every single point. To assign accommodation it is necessary to complete the entire process:

## **1. ADMISSION REQUEST**

- Fill in the self-declaration form «Application for Admission» - Attachment 1 to the Notice which can be downloaded from the website [www.fondazionezanotti.org](http://www.fondazionezanotti.org)
- It is necessary to attach to the application for admission a paper (paper or video) in which the student expresses the reasons and motivation that led to the choice of the Santa Teresa Campus.
- It is possible to attach language certifications and any other document that will be taken into consideration in support of the application for admission and will be subject to evaluation by the Commission.
- The application for admission is considered valid only if complete in all its parts and accompanied by the required attachments.

## 2. EVALUATION INTERVIEW

- The student will be contacted to define the appointment time for the evaluation interview. The interview will take place on the pre-established dates. The method of implementation (in person or online) will be agreed with the student. In case of an in-person interview, it will be possible to visit the facility. In case of an online interview, a visit must be scheduled to take place by 12 September
- The interview is mandatory, under penalty of exclusion from the ranking.

### 3. RANKING PROCESSING

The examining commission appointed by the Enrico Zanotti Foundation has a total of 100 points; in formulating the Ranking, scores will be assigned based on:

- Evaluation interview (50 points)
- Paper which highlights the student's reasons and motivations for accessing the Santa Teresa Campus (10 points)
- Qualifications such as the State Exam score, university curriculum and arithmetic average, CFU obtained, in addition to the certifications or certificates attached to the application (40 points).

The candidate's motivation for choosing university, scholastic/academic path and aptitude for community life, as well as interest in the cultural offering of the Campus, contribute to the evaluation of the interview and the essay.

To students who reconfirm their desire to remain within the structure for the academic year. subsequent and who have distinguished themselves with a meritorious educational or training path, can be awarded up to 5 points.

The Commission **will communicate** the results through the publications of the rankings on the website [www.fondazionezanotti.org](http://www.fondazionezanotti.org), assigning the accommodation place until availability is exhausted. Students "admitted NOT assigned" will remain in the ranking and will be contacted in the event of new availability.



#### 4. ACCEPTANCE OF ACCOMMODATION

The student who is an "admitted assignee" will be contacted by the Enrico Zanotti Foundation to finalize the acceptance of the accommodation place.

The assigned student will receive the booking form relating to the assigned accommodation via email, which must be signed and sent to [campussantateresa@fondazionezanotti.org](mailto:campussantateresa@fondazionezanotti.org) within the times indicated by the Zanotti Foundation.

**It is specified that acceptance of the accommodation will become effective upon signature of said form and related crediting of the non-interest-bearing deposit amount.**

The Foundation reserves the right to carry out random checks regarding the veracity of the documentation presented upon admission. False declarations or failure to pay the deposit will result in the loss of the accommodation place and the scrolling of the ranking. Assigned students who are unable to accept the accommodation will be able to agree on different acceptance deadlines, if places are available.

## SUPPORTED STUDENTS

For capable and deserving students even if they have no means (subsidized students) there are tariff concessions, as follows:

- Reduction of **€50/month** for capable and deserving students who declare an ISEE of less than €15,000

Reduction of **€20/month** for capable and deserving students who declare an ISEE equal to or less than €27,000

The ISEE requirement to be able to take advantage of the benefits must be self-declared when applying for admission (specific ISEE for benefits for the right to university study).

The assignment of places to Aided Students will take place based on the ranking criteria described in point 3.

## FOREIGN STUDENTS

It should be noted that within the Santa Teresa Campus n. 2 accommodation places are intended for foreign students.

The assignment of places reserved for foreign students will take place based on the ranking criteria described in point 3.

## FEES

The rooms are double and single equipped with a single bed, wardrobe, desk, bedside table, shelves for texts and handouts (in the common areas there are additional wardrobes available to students for seasonal changes and compartments for personal use). The contracts have a duration of 12 months (from 01/10/2024 to 25/09/2025);

- The **Annual Fee** includes everything indicated in the «SERVICES» point.
- A security deposit of €400 is required.
- A possible "EE Electricity Integration" is foreseen which will be applied only if the market value of the electricity exceeds the PUN values communicated to the guests at the start of the contract. Maximum amount payable per student is €500 per year.

## CONTRACT

The relationship between the Enrico Zanotti Foundation and each admitted student will be regulated by an annual contract and will allow them to take advantage of tax deductions in accordance with current regulations (art. 1, paragraph 208, Law no. 204/2007 - Financial Law 2008)

**The contract will be signed together with the Training Plan and the Structure Regulations from 1 October 2024.**

If the student assigned the accommodation place does not formalize the assignment of the accommodation place with a contract, he will lose the booking confirmation deposit.

## TRUTH OF THE STATEMENTS

All the information indicated in the Application for Admission is to be considered self-declaration and therefore the declarant is responsible for the declarations made and forfeits the benefits obtained if the untruthfulness of the content of the same emerges. Untrue statements are punished pursuant to the Penal Code and special laws on the matter (art. 75 and 76 Presidential Decree of 28 December 2000, n. 445). Fondazione Zanotti, in turn, with the means at its disposal, will be able to carry out checks on the declarations produced, reserving, where necessary, the right to request additional documentation.
